



EVENT RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

IN CONSIDERATION of being permitted to participate in the _____, Event and any and all of the activities related to said Event (hereinafter referred to as "the Events"), I, the undersigned Releasor, agree that:

1. I know and understand the nature of the Events and believe myself to be qualified to participate in the Events. If I believe anything is unsafe, I will immediately cease participation and refuse to participate further in the Events.
2. I know and understand that my participation in the Events involves risks and dangers caused by my own actions, inactions, the actions and inactions of others, the rules of the Events, the condition, maintenance and layout of the premises and equipment, including risks not known to me or that are not readily foreseeable at this time and dangers of serious bodily injury, including but not limited to, permanent disability, paralysis and death (hereinafter referred to as "Risks").
3. I know and understand that personal injuries, losses or other damages could result from such Risks and that such injuries, losses or damages could be severe and permanent.
4. I know and understand that my participation in the Events is purely voluntary and I am in no way obligated by the City of Guymon, Oklahoma or any permittee or event sponsor authorized by the City of Guymon or their respective directors, officers, employees, agents, successors and assigns (hereinafter referred to as "Releasees") to participate in the Events.
5. I hereby assume responsibility for all personal or property losses, including but not limited to damages to me or my property, including damages for injury, disability, paralysis or death arising from my voluntary participation in the Events, even if caused or alleged to be caused, in whole or in part, by the negligence of Releasees or their agents, servants or employees.
6. I hereby accept such Risks and hereby waive any and all claims which may accrue to me or my successors in interest against the Releasees and I release and discharge the Releasees from any and all liability to me, my personal representative, assigns, heirs, and next of kin for any and all claims, demands, losses or damages on account of any injury, including but not limited to disability, paralysis, death or damage to property arising out of my voluntary participation in the Events, whether caused or alleged to be caused, in whole or in part, by the negligence of Releasees, their agents, servants or employees and I covenant not to sue the Releasees.
7. If despite this release, I, or anyone on my behalf, makes a claim or demand against Releasees, I agree to indemnify and save and hold harmless Releasees from any and all litigation expenses, attorney fees, loss, liability, damage or cost they may incur due to the claim or demand made against Releasees, regardless of the basis of the claim.

I have read the above release, waiver of liability, assumption of risk and indemnity agreement and understand that by signing it, I give up substantial rights I would otherwise have to recover damages for losses, and sign it voluntarily and without inducement.
